A CASE OF LINEAR VERRUCOUS HAEMANGIOMA

Verrucous haemangioma is a rare congenital vascular malformation of the cutaneous and sub-cutaneous tissues with a predilection for the lower extremities. Although almost invariably present at birth, it may appear later or even in adult life. The linear variant of verrucous haemangioma is extremely rare and only a few cases have been reported. Hence, we are reporting this case for its extreme rarity.

Case report:

A 9yr. old boy presented to our clinic with the chief complaints of an expanding growth over his left lower leg and feet. The lesion was present since birth as a small red or bluish-red macule located on the lower third of the left leg, which started increasing in size since 1yr. of age. The growth was slow till the child became 8yrs. of age after which it started increasing rapidly involving the entire lower third of the left leg as well as part of the dorsum of the left foot. At places it developed thick crusts with verrucosities that often bled after minor injury. The patient subsequently developed pain over the affected part.


On Examination, a linear well circumscribed plaque about 30 x10 cm. in size was seen involving the lower third of the left lower leg and half of the dorsum of the left foot. The margin was dusky red in colour and showed evidences of peripheral extension along with central clearing. However, no evidence of scarring was seen. Erythema and papules were present over the margins, while at places heaped up crusts with resultant varrucosities were seen. On applying pressure blood mixed with sero-sanguinous discharge could be expressed out from the crusted lesions. There was, however, no discrepancy in the limb length in comparison to the other limb.




Keeping in mind the differential diagnosis of Verrucous Haemangioma, Haemangioendothelioma, Lupus Vulgaris and Deep Mycosis, we proceeded to do the necessary investigations.

The routine investigations were within normal limits and the Montoux test was negative. To establish the diagnosis, we did a punch biopsy using a 4mm. size punch from a verrucous area of the plaque.

Histopathology from the lesion revealed a substantial increase in the number of dilated and tortuous capillaries within a thickened papillary dermis, which also extended to involve the deep dermis and subcutis. Some of the capillaries had thickened walls and were engorged with RBCs. Overlying epidermis showed moderate acanthosis, hypergranulosis and compact hyperkeratosis. No organism or granuloma was found.

With the above findings, the diagnosis of 'Linear Verrucous Haemangioma' was made. Management:

Most of the literatures have suggested that a wide and deep excision is the treatment of choice in verrucous haemangioma because of the deep angiomatous proliferation. However, as suggested by some other studies, we are planning a session of Cryotherapy or CO2 LASER and see the response.

ACSICON 2011: REMINISCENCES & REVERBERATIONS

The 10th National Conference of Association of Cutaneous Surgeons of India [ACS(I)] - ACSICON 2011 - was held at IORA Retreat, Kaziranga on November 25-27, 2011. The conference had its genesis on the banks of the Dal Lake one wintry evening in October, 2009 during the ACS(I) Workshop at Srinagar. Overwhelmed by the scenic beauty of Kashmir and the success of the workshop in an exotic place such as Srinagar, the then ACS(I) executive voiced their willingness to explore other such sylvan and idyllic locations for future ACS(I) meets. Their sights zeroed in on Kaziranga, Assam!

As the North East States Coordinator of ACS(I), I was asked to explore the feasibility of organizing the event at Kaziranga. Despite all odds, both personal and professional, the fierce zeal to showcase the very best of our region and establish its identity in the national conference map motivated me to agree to take up this monumental responsibility. I was officially appointed the Organising Secretary of the 10th National Conference of ACS(I) at the subsequent ACS(I) Executive meeting at Lucknow in January, 2010 and this was ratified by the ACS(I) General Body at Aurangabad in November, 2010.

Organising a conference of national magnitude in the cloistered environs of Kaziranga, with limitations of resources and logistics, was a herculean task in itself. Moreover, the fact that ACS(I) had only a handful of members in the entire North East, heightened the enormity of the assignment. The leadership of the pioneer of dermatosurgery in this region, Dr. K. N. Organizing Barua, as the Chairperson settled lot of hassles and gave direction to the efforts. Team ACSICON 2011 was fortunate to have on board the experience and reliability of Dr. K. C. Talukdar, Dr. R. K. Gogoi, Dr. E. M. Ovung, Dr. Krishna Talukdar & Dr. B. K. Nath and the energy and dynamism of the young brigade led Dr. Anupam Agarwal & Angshuman Bhattacharjee. Thus, thanks to the collective hard work, cooperation, support and guidance of NEIADVLites, many of whom subsequently became ACS(I) members, ACSICON 2011 could, eventually, surmount all odds and turn out to be a milestone conference in the annals of ACS(I). Many delegates remarked that it was a landmark event which will be remembered, cherished, and talked about, for a long time!

The inaugural function of ACSICON 2011 was held on November 25th. The welcome address was given by Dr. K. N. Barua, the Organising Chairperson. The ACS(I) President. Dr. Venkataram Mysore, in his Presidential address, urged the delegates to make dermatosurgery their passion, research an obsession and service the ultimate mission. Dr. J. C. Mahanta, Director, RMRC, NE Region, ICMR graced the occasion as the Chief Guest and lit the ceremonial lamp. He outlined the various research activities funded by ICMR and stressed the need for young dermatologists to submit research proposals and projects to utilize these resources. The scientific deliberations

of the conference started off in parallel halls with sessions on mastering the basics, wound healing and scar revision surgery. The highlight of the opening day was the P. N. Behl Oration delivered by Dr. Vinay Saraf. This was followed by a marathon session on lights & lasers and an interactive 'Meet the expert" session. The second day had sessions on vitiligo surgery, hair raising solutions, surgical management of acne scar, chemical eels, botulinum toxin and fillers, cryosurgery and pearls and pebbles in dermatosurgery. Several interesting papers were presented in the award paper session. The winners were Drs. Tolongkhomba (Imphal), Reshma Gadkari (Mumbai) & Nandini A. S. (Bengaluru) respectively. The final day of the conference featured the Potpourri session and the free papers. Eminent faculty from across the country enriched the scientific deliberations with their knowledge, skill and vast experi-

The inaugural ACS(I) - Dr. Reddy's Dermatosurgery Quiz for Residents was held at Kaziranga. The preliminary screening round was conducted by Dr. Niteen Dhepe & Dr. Raghunatha Reddy on 25th afternoon. Teams from Assam Medical College & Hospital. Dibrugarh; Topiwala National Medical College & Nair Hospital, Mumbai; D. Y. Patil Hospital & Research Centre, Mumbai; and AIIMS, Delhi progressed to the final round. The finals were held as a plenary session on 26th morning. The Quizmaster, Col. Dr. Manas Chatteriee, as is his wont, put the teams through a stern test. At the end of 8 grueling rounds covering the gamut of surgical and aesthetic dermatology and a rapid fire round, there was a tie for the top position between TNMC & DY Patil. In the tie-breaker round, TNMC (Drs. Reshma Gadkari & Atul Giri) edged out DY Patil (Drs. Maniot Marwah & Neha Saboo) to be crowned the worthy winners. ACSICON 2011 was, however, not all about academics. The scientific sessions were slotted later in the mornings to allow the delegates ample time to go for morning safaris and explore the biodiversity of the World Heritage site. Accompanying persons, too, were kept busy with excursions and activities throughout the day. The lunches and dinners had carefully chosen menus reflective of both local and national Cultural programmes cuisine. showcasing the ethnic bountiness and cultural diversity of the region were organized in the evenings. The non-stop fiesta led one delegate to comment that the only thing he missed during the conference was boredom! Another senior faculty remarked that it was, indeed, a perfect blend of academics and a cultural and culinary feast!

Although the conference officially concluded on the 27th afternoon with the valedictory function, the wilderness of Kaziranga continued to echo the unbridled joy and spontaneous exultation of the delegates, many of whom had exclaimed that "the warmth, personal touch and fantastic hospitality made this conference stand apart from all the other conferences". One much esteemed national faculty remarked that "it was one of the best ever conferences organized in the country and certainly the best ever that I have attended". The spontaneous comments written on the ACSICON 2011 Facebook group page and posted in the IADVL Yahoo groups left no one in doubt about the unqualified success of the conference.

The legacy of the uniqueness of ACSICON 2011 continued even after its formal closure. It became one of the very few conferences, if any, to issue registration refunds to all those delegates who could not attend the event due to various reasons. Even then Team ACSICON could contribute a record amount of 6.5 lakh rupees to the parent association! At the same time, a substantial sum was kept for creation of Dermatosurgery fund exclusively for conduct of workshops and CMEs in surgical and aesthetic dermatology in this region.

The upshot of the success of ACSICON 2011 and the positive feedback from all quarters has been the announcement of a slew of incentives for the North East oriented to promote Dermatosurgery

in this region and encourage research and active participation in his specialty and the association. As many as three grants/awards specific for members of the North East were cleared by the ACS(I) General Body at New Delhi in April, 2012. These are as under:

- a) One travelling grant (air fare at least 30 days earlier by budget carrier) to ACS(I) member from North-East whose paper has been accepted in award paper session in ACSICON; if no paper is accepted for awardpaper, best free paper/poster will be selected by Scientific Chairman. Maximum amount Rs. 8000/-.
- b) One award of Rs. 5000/to any original work accepted for publication in JCAS. It should be a study and not a case report. Applicant should be an ACSI member from the North-East.
- c) One travelling grant (air fare at least 30 days earlier by budget carrier) to ACS(I) member from North-East for training fellowship in a centre of his choice under the ACSI Fellowship/other training programme under ACS(I). Application has to be recommended by ACS(I) Coordinator of North-East States. Maximum amount Rs. 8000/-.

It is a pleasure to mention that the services rendered by Dr. Rajib Kr. Gogoi as the trusted and able custodian of the ACSICON 2011 funds was recognized by ACS(I) and he has been appointed as the Convener of the ACS(I) National Registry Dermatosurgery, the first of its kind in the country, for systematic documentation of surgical procedures performed across the country. The dynamism of Dr. Birendra Kr. Nath as the Scientific Secretary has also been acknowledged by his appointment as the Chief Moderator of the ACS (I) Facebook group. I hope all of us gear up to utilize these incentives and contribute to the collective glory of this region. I am sure this wonderful gesture of the ACS(I) Executive and General Body will go a long way in encouraging and inspiring the members of this region to take to this subspecialty in large numbers and develop expertise in the same.

I once again take this opportunity to place on record my deepest gratitude to all of you who made ACSICON 2011 the success that it turned out to be.

Discussion:

The term 'Verrucous Haemangioma' was first used by Halter in 1937 and further described in detail as a distinct entity by Imperial and Helwig. Very few cases of Linear Verrucous Haemangioma have been reported so far. There is no consensus on whether they follow the distribution of the 'Lines of Blaschko'. It has been proposed that these lesions may actually be following dermatomal patterns or that the linear arrangement represents genetic mosaicism..

This case has been reported for the sheer rarity of its presentation.
